ITEM NO.3: Continuation Of Mr.S.Balakrishnan (DIN 01467766), AS AN INDEPENDENT DIRECTOR OF THE COMPANY.

Mr.S.Balakrishnan (DIN 01467766) was appointed Director of the Company, under the category of Independent Director with effect from 13th October,2021, for a term of 5 years. Pursuant to the provisions of Sections 149, 150, 152, 160, 161, read with Schedule IV and other applicable provisions, if any, of the Companies Act, 2013 ('Act') and the Companies (Appointment and Qualification of Directors) Rules, 2014 as well as other Rules made thereunder and pursuant to applicable provisions of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations'), as amended (including any statutory modification(s) or re-enactment(s) thereof for the time being in force), the provisions of the Articles of Association of the Company and based on the recommendation of the Nomination and Remuneration Committee and approval of the

of the Board of Directors of the Company. Further, Mr. S.balakrishnan has confirmed that he is not disqualified to act as a Director in terms of Section 164 of the Act and he is not debarred from holding the office of Director by virtue of any SEBI order or any other such authority and he is in compliance with Rule 6 of the Companies (Appointment and Qualification of Directors) Rules, 2014.

Given his expertise, knowledge and experience, the Board is of the opinion that it would be in the interest of the Company to avail his services as an Independent Director of the Company and his continuation on the Board of the Company as an Independent Director even after attaining the age of 75 years will be in the interest of the Company and he has given his consent to act as a Director of the Company. Further, as per Regulation 17(1A) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 inter alia, provides that "no listed company shall appoint a person or continue the directorship of any person as a non-executive director who has attained the age of 75 (seventy-five) years unless it is approved by the members by passing a special resolution to that effect. Mr. S.Balakrishnan will attain the age of 75 years on 6th February, 2025 and hence continuation beyond 75 years requires the approval of members by way of a special resolution. The provisions of Section 71, 180(1) (a) & 180 (1) (c) of the Companies Act 2013 provide that the Board of Directors of a Company shall exercise the powers for creation of such pledges, mortgages and/or charges on all or any of the immovable or movable properties of the Company wheresoever situated, present and/or future, including any or all shares held by the Company, to secure the repayment(s) of any loan(s) availed or to be availed of, or any debenture(s) issued or to be issued by

2. Company Performance

During the year the turnover of the company increased to Rs.6832.24 Lakhs compared to Rs.5846.31 lakhs in the previous year. This is a 17% increase over the previous year. The orders are steady and the company plans to grow it turnover at an increased pace during the current year 2024-25.

Regarding the exceptional income reported, it pertains mainly to the amount received against the slump sale of the company envisaged in 2018 but dropped later in November 2019 due to non completion of payment of the total consideration by the proposed buyer and no correspondence regarding the same in the last five years, the amount was written back during the year based on legal advice.

3. Dividend

The Directors have not recommended any dividend for the year under report.

4. Reserves

Your Directors do not propose to transfer any amount to the general reserves and the entire amount of profit for the year forms part of the 'Retained Earnings".

5. Borrowings

There are no borrowings from banks or financial institutions.

6. CORPORATE MATTERS

6.01 Human Resources

El Forge has always been a people driven Company and its employees remain its most valuable asset. Our employees have always extended full cooperation and support during good as well as difficult times, and have unstintingly put their best effects to deliver on all our commitments.

The Human Resources practices at your Company empowers the employees through greater knowledge, opportunity, responsibility, accountability and reward. Emphasis is laid on identifying & nurturing talent. At present the Company has Four directors of which one director is an Executive Director and Three are nonexecutive.

The Company is following all the applicable Accounting Standards for properly maintaining the books of accounts and reporting financial statements. The Company ensures proper and adequate systems and procedures commensurate with its size and nature of its business even though there is no internal auditor during the year under report.

Overview

The objective of this report is to convey the Management's perspective on the external environment and forging industry, as well as strategy, operating and financial performance, material developments in human resources and industrial relations, risks and opportunities and internal control systems and their adequacy in the Company during the FY 2023-24.

This should be read in conjunctions with the Company's financial statements, the schedules and notes thereto and other information included elsewhere in the Integrated Report. The Company's financial statements have been prepared in accordance with Indian Accounting Standards ('Ind AS')complying with the requirements of the Companies Act, 20213 as amended and regulations issued by the Securities and Exchange Board of India ('SEBI') from time to time.

Global Economy

The global economy continued to grow at a modest pace of 3.1% in 2023 and 2024. A slight pick up to 3,2% is expected in 2025. The impact of tight monetary conditions continues to be felt in credit markets, but the global activity is proving to be resilient as private sector confidence is improving coupled with decline in inflation. The outlook continues to differ across countries with weaker outcomes in many advanced economies especially in Europe. The emerging market economies and United States project strong growth prospects. The global inflation is forecast to decline steadily from 6.8% in 2023 to 5.9% in 2024 and 4.5% in 2025. The Global economy is resilient despite significant Central Bank interest rate hikes.

Indian Economy

Indian economy has grown from strength to strength in the recent years. India is currently the 5th largest economy in the world. Indian economy continues to grow at a rate of approximately 8.4% in 2024 surpassing expectations. Increased Government capital spending, firm domestic demand, strong revenue collections have all contributed to the growth. India is performing well economically with strong growth projections for the coming years. The implementation of ambitious set of reforms has supported economic activity and helped put a break on inflation.

Outlook

India's GDP took a big leap on Leap Day in 2024: The country's remarkable growth rate of 8.4% in the third quarter of the fiscal year 2024¹ surpassed all expectations, as market analysts had penciled

in a slower growth this quarter, between 6.6% and 7.2%. Deloitte's projected growth for the quarter was between 7.1% and 7.4% (as published in January 2024

In this edition of India economic outlook, the focus is on the emerging consumer spending patterns in India, highlighting the rise of the middle-income class. Not only has growth in consumer spending post pandemic been fluctuating, but there is also a shift in consumption patterns, with demand for luxury and high-end products and services growing faster than demand for basic goods. As we expect the number of middle- to high-income households with increasing disposable income to rise, this trend will likely get further amplified, driving overall private consumer expenditure growth.

Indian Auto Industry

The Indian automobile industry has historically been a good indicator of how well the economy is doing, as the automobile sector plays a key role in both macroeconomic expansion and technological advancement. India enjoys a strong position in the global heavy vehicles market as it is the largest tractor producer, second-largest bus manufacturer, and third-largest heavy truck manufacturer in the world.

The Government of India encourages foreign investment in the automobile sector and has allowed 100% FDI under the automatic route. Some of the recent initiatives taken by the Government of India are:

In January 2024, the Ministry of Heavy Industries extended the tenure of the Production Linked Incentive (PLI) Scheme for Automobile and Auto Components by one year. The incentive will now be applicable for a total of five consecutive financial years, until March 31, 2028.

India is on track to become the largest EV market by 2030, with a total investment opportunity of more than US\$ 200 billion over the next 8-10 yea The automobile sector received a cumulative equity FDI inflow of about US\$ 36.268 billion between April 2000 - March 2024strong demand.

Opportunities & Threats

The government has developed numerous programs to help manufacturers, such as the Production Linked Incentive (PLI) Scheme, which is a cornerstone of the government's endeavour to achieve an Atmanirbhar Bharat • The scheme's goal is to stimulate domestic manufacturing in strategic and emerging areas, improve the cost competitiveness of domestically-made goods, and increase local capacity and economies of scale • Domestic producers are given a preference in the defence sector which will provide new opportunities to the industry .

A faster shift to electric vehicles, will have a impact on our business • Several new companies are entering the market, and existing rivals in adjacent product categories are also increasing their offerings. Under utilisation of the installed capacity resulting in increasing fixed costs of the company, growing cost of key raw materials may impact revenues and profitability of the company.

Risk Management

The Company has a well-devised risk management process aimed at identifying, prioritizing, mitigating and monitoring risks. The key risks impacting its business include economic, foreign exchange, raw material, technology, funding, talent and cyber security risks. The Company has undertaken measures to mitigate these risks.

Commodity Price Risk

The Steel prices have increased substantially during the year and continues to be on the upward spiral. The increases are compensated from customers. Other input costs are also increasing and the company deals with obtaining compensation from customers on a case to case basis.

Financial and Operational Performance:

The Company has undertaken numerous operational initiatives to improve performance and reduce material loss. Undertaken impactful actions to make its quality control process robust and reduce cost of production. We have implemented strict control on raw material purchase and implemented productivity measures, both manpower and machine productivity. Also a number of cost control and cost management measures were initiated during the periods of slowdown this year to improve the financial performance.

Revenue is earned from sale of services, which involves materials for jobwork. Revenue is recognized upon completion of services or upon transfer of risk and reward of products (in respect of job-work materials sent after completion of the service) to the customer.

Revenue from rendering of services is recognized upon completion of services and all the obligation under the contract has been performed and the Company has an enforceable right to payment for services rendered

Leased assets are depreciated over the shorter of the lease term and their useful lives unless it is reasonably certain that the Company will obtain ownership by the end of the lease term.

04.03. Loans and Borrowings

In case of revalued assets such reversal is not recognised.

04.09. Cash and cash equivalents

Cash and cash equivalent in the balance sheet comprise cash at banks and on hand and short-term deposits with an original maturity of three months or less, which are subject to an insignificant risk of changes in value. For the purpose of the statement of cash flows, cash and cash equivalents consist of cash and short-term deposits, as defined above

04.10. Provisions

04.10.01. Provisions are recognized if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation. If the effect of the time value of money is material, provisions are discounted using a current pre tax rate that reflects, where appropriate, the risks specific to the liability. Where discounting is used, the increase in the provision due to the passage of time is recognized as a finance cost.

(b) Provident Fund

Eligible employees of the Company receive benefits from a provident fund, which is a defined benefit plan. Both the eligible employee and the Company make monthly contributions to the provident fund plan equal to a specified percentage of the covered employee's salary. The Company contributes a portion to the Govt. Provident Fund Trust. The trust invests in specific designated instruments as permitted by Indian law. The remaining portion is contributed to the Government administered pension fund. The rate at which the annual interest is payable to the beneficiaries by the trust is administered by the Government.

Considering the failure of the Buyer to honour their commitment, the Board had dropped the Slump sale and intimated the same to the buyer and BSE Ltd. There has been no response from the Buyer in respect of the aforesaid communication.

As there had been no developments in the matter, the company has analysed the legal implications and based on the legal opinion which clearly stated that there is has been no subsisting obligation under the MOU to return the amounts to the Buyer and it is would not be necessary to reflect these amounts as liabilities in the books of account of the Company. Hence the amount of Rs.7056.02 Lakhs (Rupees Seven Thousand Fifty Six point Zero Two Lakh only) was written back as this would be in the best interest of all stakeholders.

While taking the aforesaid action, the Board has noted that the matter might be subject to the adjudication of any legal claims in future by the Buyer. In that eventuality, the Company may make a counter claim or a fresh negotiation.
